TO EASE SNOW REMOVAL:

Apply DEEP THAW® at the beginning of snow storm, if possible. Broadcast approximately 1/4 oz. per square yard of area to be treated.

FOR ICE REMOVAL:

Apply DEEP THAW® evenly over surface at the rate of approximately 8 oz. (1 cup) per square yard of area to be treated for each 1/4 inch of ice.
